Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Lamoine, in said county, qualified by law to vote in town affairs, to meet at the Lamoine Town Office in said town on Tuesday, June 10, 2014 at 7:55 AM then and there to act by secret ballot vote on articles 1 through 2, polls closing on article 2 at 8:00 PM both of said articles being set out below, to wit:

1. To choose a moderator to preside over said meeting.
2. To vote by secret ballot referendum on the following question:

Shall Part I. Section 4. H. Table of Land Uses of the Town's Building and Land Use Ordinance be amended to prohibit "Mineral Exploration" within the Residential Zone and within the Rural and Agricultural Zone (RAZ) and to prohibit "Sand/Gravel Pits, etc." within the RAZ, except that land within the RAZ that had received or applied for a Site Plan Review permit for gravel operations before March 13, 2013, may continue to be eligible for gravel operations upon Planning Board approval of a gravel permit? Subsections 16 and 27 would be amended to read as follows:

Land Use Description	Residential Zone (RZ)	Development Zone (DZ)	Rural & Ag Zone (RAZ)
16. Mineral Exploration ²	N	PB	N
27. Sand/Gravel Pits, Etc. ²	N	PB	N ³

³ Land within the Rural and Agricultural Zone that had received or applied for a Site Plan Review permit for gravel operations before March 13, 2013, may continue to be eligible for gravel operations upon Planning Board approval of a gravel permit.

STATEMENT OF PURPOSE

The purpose of this amendment is to limit "Mineral Exploration" and "Sand/Gravel Pits, etc" to the Development Zone.

INFORMATION

This article was presented by a citizen's petition presented to the Lamoine Board of Selectmen on February 6, 2014.

A person who is not registered as a voter in the Town of Lamoine may not vote in any election.
